DOWNEAST LAKES LAND TRUST (DLLT) MANAGES ITS CONSERVATION LANDS FOR THE LONG-TERM ECONOMIC AND ENVIRONMENTAL WELL-BEING OF THE REGION. THE 33,708-ACRE FARM COVE COMMUNITY FOREST IS MANAGED FOR WILDLIFE HABITAT, SUSTAINABLE TIMBER HARVEST, AND PUBLIC RECREATIONAL ACCESS. DLLT HOLDS AN INDEPENDENT THIRD PARTY FOREST MANAGEMENT CERTIFICATION. WILDLIFE HABITAT AND TIMBER MANAGEMENT ARE INTEGRATED TO MAINTAIN HABITATS FOR THE FULL RANGE OF NATIVE WILDLIFE ON A LANDSCAPE SCALE. DLLT HAS IMPROVED RECREATIONAL ACCESS BY MAINTAINING FOREST ROADS, ESTABLISHING AND MAINTAINING THREE HIKING TRAILS AND THE DOWNEAST LAKES WATER TRAIL. DLLT TIMBER HARVESTS SUPPORT THE LOCAL ECONOMY, WHILE WILDLIFE HABITAT AND RECREATIONAL ACCESS IMPROVEMENTS SUPPORT NATURE-BASED TOURISM

DOWNEAST LAKES LAND TRUST (DLLT) PLANS AND IMPLEMENTS CONSERVATION PROJECTS INTENDED TO PERMANENTLY CONSERVE NATURAL RESOURCES INCLUDING WILDLIFE HABITATS AND SUSTAINABLE TIMBER HARVESTS AND GUARANTEE PUBLIC RECREATIONAL ACCESS TO HIGH PRIORITY FOREST, WETLAND, AND LAKEFRONT PROPERTIES IN THE DOWNEAST LAKES REGION OF MAINE.
